Terms of Call for Installed Pastors

Action Item: Proposed Amendment to the Standing Rules
The Commission presents an amendment regarding Temporary and Corresponding Members. The proposed Amendment would be an addition to Article 1, Section 2.

Membership shall also consist of temporary and corresponding members.

a. Temporary membership may be granted on a yearly basis by a majority vote of the presbytery at the recommendation of the Commission on Ministry and Preparation, and is granted to those serving specific congregations on a contractual basis, but are not Teaching Elders in the PC(USA). Temporary members shall have both voice and vote.

b. Corresponding membership may be granted to members of other presbyteries, denominations, or PC(USA) affiliated organizations who are present at presbytery meetings. Members shall be seated each meeting by a motion from the presbytery floor. Corresponding Members shall have voice, but no vote.
